### Scheduled Election

*Fair Work (Registered Organisations) Act 2009*

**Nominations** are called for offices in the Manufacturing Division of the Construction, Forestry, Mining and Energy Union. The offices for which nominations are called are set out in Attachment A.

**Nominations**, which must be in writing and comply with the registered rules of the Union may be made at any time from 22/03/2021.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Union's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than** 12:00pm (Noon) Australian Eastern Standard Time (AEST) **on** 06/04/2021.

**How to lodge nominations**, nominations must be lodged via the following method:

**By Email:** A properly completed nomination form including all necessary signatures and attachments may be scanned and submitted as a pdf file to [IEBnominations@aec.gov.au](mailto:IEBnominations@aec.gov.au).

### Withdrawing Nominations

Nominations cannot be withdrawn after 12:00pm (Noon), Australian Eastern Standard Time (AEST) on 20/04/2021.

### Candidate Statements

As per Rule 32(c) (v) "Candidates may include with their nomination form, a statement not exceeding 200 words and in respect of **District Management Committee** member **50 words**, containing only the candidate's personal history and only the candidate's policy." Only statements which comply with the Rules and are received by the Returning Officer by 12:00pm (Noon) Australian Eastern Standard Time (AEST) on 06/04/2021 can be accepted.

### Scrutineer Appointment

In accordance with Rule 32 (c) (xvi) "Any candidate at their own expense may appoint a financial member of the union to act as their Scrutineer by notification in writing to the Divisional Returning Officer". A Scrutineer Appointment form is available from the Returning Officer.

### Voting Period

The ballot, if required, will open on 18/05/2021 and close at 10:00am Australian Eastern Standard Time (AEST) on 16/06/2021.
