Statements must be submitted **not later than** 4:00pm (AEDT) on 19/02/2019.

### **Voting Period**

The ballot, if required, will open on 19/03/2019 and close at 10:00am Australian Eastern Standard Time (AEST) on 09/04/2019.

**Scrutineers**

Candidate may appoint a financial member of the Union to act as their scrutineer. A form is available from the Returning Officer for the purposes of appointing Scrutineers.
