Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than 4:00pm Local Time** (office of the Returning Officer) **on 17/02/2020**.

By Email: A properly completed nomination form including all necessary signatures and attachments may be scanned and submitted as a pdf file to saelections@aec.gov.au

1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.

Withdrawing Nominations

Nominations cannot be withdrawn after 4:00pm Local Time (office of the Returning Officer) on 02/03/2020.

Candidate Statements

Candidates may submit a statement to be included with ballot material. Only statements which comply with the Rules and are received by the Returning Officer by 4:00pm (Local Time (office of the Returning Officer)) on 17/02/2020 can be accepted.

Voting Period

The ballot, if required, will open on 23/03/2020 and close at 12:00 noon Local Time (office of the Returning Officer) on 06/04/2020.

Scrutineers

The appointment of scrutineers opens 23/03/2020 and closes 12:00 noon Local Time (office of the Returning Officer) on 06/04/2020.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
